2. Cars running under 12.99 seconds must seek prior approval before entering the event due to safety reasons.
3. All competitors must have a suitable helmet.
4. Closed footwear is required for drivers.
5. No passengers are allowed in the cars whilst competing.

1. Indemnity:

I have received the Supplementary Regulations and all other regulations or Articles as determined in the Appendices and Schedules for the event that I am entering and agree to be bound by them.
